1. Explain what is meant by the "double cure." When Jesus died, He bore not only our iniquities, but also our sicknesses. In the atonement is salvation for the soul, and healing for the body. Salvation and Healing

2. Answer properly the following objection to divine healing:

"The age of miracles is past." It is said that Jesus used miracles to establish the church but that miracles are not needed today. This statement is far from being true. If ever there was a time when the world needs a gospel with signs following, it is today. This is still the same church dispensation.
