 - 1) He was the spiritual head at home (Genesis 12:8; Exodus 12:3).
 - 2) He (with the help of his wife) was in charge of the education of their children (Proverbs 22:6; Deuteronomy 6:7-9), especially the passing of truth (God's law) from generation to generation.
 - 3) He was in charge of the wise and loving discipline of his children (Proverbs 13:24; Hebrews 12:5-11). This included being a godly example.
 - 4) He was supposed to provide for his family's needs (Proverbs 6:6-11; 1 Timothy 5:8).
- 5. How many times does the Word of God record God talking to His children with a direct statement such as "God said," "thus saith the Lord," "the Lord said," "God saith," "Jesus said," "Jesus saith," or "the word of God?" God is a Father who loves to talk to His children and this is recorded more than 1,200 times.
- 6. Why does a man's choice of a wife affect their children so seriously? A man and his wife were meant to work together so closely to train their children in the ways of the Lord. If he chooses an ungodly wife, the possibility of her turning him to follow other gods is very strong. This means the leadership of the family can be turned from truth and the whole family will follow. (Read 2 Corinthians 6:14 and Deuteronomy 7:2-3.)

7. What can we learn from each of these fathers?

Abraham – teaches us to wait patiently for God's promises.

Jacob – teaches us to be careful not to sow deceit and favoritism among our children.

Joshua – teaches that it is necessary to train the next generation carefully and prayerfully.

Gideon – teaches that polygamy and lack of Godly leadership is dangerous to the future of our children. Samuel - teaches that a lack of godly discipline has far-reaching effects on our children and all those associated with them.

- 3. List four (4) reasons why the rebuilding of the Jerusalem wall was so important to Israel.
 - 1) Gangs of thieves were stealing anything they wanted from the city.
 - 2) There was no security inside the walls, so people were living with foreigners and idol worshippers.
 - 3) This close living led to marriage with those who did not know and follow God's laws and ways.
 - 4) This intermarriage led to the loss of their language, culture, and religion.
- 4. In what four (4) ways does divine discipline give us the proper example to follow for disciplining our children?
 - 1) Divine discipline is proof that God loves His children. He will never abandon them or correct them abusively because He is angry with them.
 - 2) Divine discipline is meant to help His children become holy.
